Inaugural Meeting on 11<sup>th</sup> November 2021.



Inaugural Meeting on 11<sup>th</sup> November 2021: Minutes of Meeting being signed by the Head of the Papuan Customary Council (DAP).

Goodhope is working with stakeholders in the Nabire region of Papua to establish a 'Kawasan Ecosystem Essential' (KEE) across an area of 107,581.66 ha. The KEE is outside of existing conservation areas and has ecologically important values that support biodiversity and the welfare of local communities.

A proposal to designate the area as a KEE has been developed in collaboration with our partners, PILI Green Network and IDH Sustainable Trade Initiative. The area spans 9 districts and includes habitat for endemic and endangered species.

A meeting in November 2021 was held in preparation of the KEE Assessment and Proposal development. The meeting on 11<sup>th</sup> November 2021 was attended by representatives of Papuan Customary Councils, Indigenous Peoples Institutions, universities, NGOs, companies, and village heads.

Initial stakeholder engagement processes involved the formation of a KEE Assessment and Proposal Implementation Team, comprising 28 representatives from the various organizations in Nabire. The implementation team has been formed by the Papua Natural Resources Conservation Center (BBKSDA Papua) with support from other stakeholders in Nabire Regency.

The views of stakeholders at the district level were sought through public consultation in Nabire on 22<sup>nd</sup> November 2021. Feedback has been used to support and improve the KEE assessment and proposal.

The establishment of KEE will become an important part of green economy development in Nabire Regency through the IDH Production, Protection and Inclusion (PPI) approach for sustainable landscape management. This approach aims to increase business productivity (production), forest protection and conservation (protection), and increase farmer and community income (inclusion) in global-scale commodity supply chains.

The proposal furthermore supports mandates of the Ministry of Environment and Forestry to identify areas of high biodiversity value, and supports policies for Green Growth Plans, regional action plans for greenhouse gas mitigation (RAD-GRK) and Provincial Strategy and Action Plans for REDD+ implementation (SRAP REDD+).

## ISCC Certification



PT Agro Indomas, Central Kalimantan (AICK) has undergone third party audit for ISCC (International Sustainability and Carbon Certification). ISCC is an international certification system that validates: Protection of land with high biodiversity value or high carbon stock; Deforestation free supply chains; Environmentally responsible production to protect soil, water and air; Safe working conditions; Compliance with human rights and labour laws and international treaties; Monitoring of greenhouse gas (GHG) emissions; Good management practices. An, labour and land rights. Audit was conducted from 22<sup>nd</sup>-27<sup>th</sup> November 2021 at PT AICK.

## Occupational Health Testing



Work Environment Quality Assessments and employee health checks are carried out routinely as part of efforts to prevent and reduce work-related injuries or illnesses.

Assessments at our palm oil mills and plantations include the testing of mechanical vibration, lighting, dust levels in the environment, and ammonia gas in the pesticide warehouse. Annual audiometric examinations are carried out for workers who work in noisy areas, such as workers in mills, workshops and generator operators in estates. Spirometry tests to monitor lung condition are furthermore carried for workers that handle agrochemicals, or that work in dusty areas or areas where chemicals are stored.



Our refining and manufacturing facilities in Malaysia (Premium Vegetable Oils) appointed Astar Laboratory to conduct Indoor Air Quality (IAQ) assessment of work areas. The purpose of this assessment is to monitor and evaluate the air quality within and around company buildings and to comply with Industry Code of Practice on Indoor Air Quality 2010.

The following parameters are monitored:

- 1) Chemical contaminant (Carbon monoxide, Formaldehyde, Ozone, Respirable particulates-PM10, TVOC).
- 2) Biological contaminant (Total bacteria counts and Total fungal counts).
- 3) Ventilation Performance Indicator (Carbon dioxide)
- 4) Physical parameter (Air temperature, Relative humidity and Air movement)





## COVID-19 Antigen Testing and Vaccination Activities



Premium Group in Malaysia is conducting COVID-19 rapid testing for all employees that return to the workplace. The tests are a compulsory requirement for manufacturing industries in Malaysia and are being conducted by the company every fortnight. This is a proactive measure to curb the spread of COVID-19 among employees and ensures that employees who return to workplace are fit to work.

COVID-19 vaccination programs continue with the immunization of employees of PT NB and SAP in Nabire, Papua, in collaboration with Yaro Health Center.

## Teacher First Aid Training



First aid training for teachers was conducted in October 2021 to provide teachers with the necessary skills and knowledge to prevent and handle a children's health emergency situation. Teachers from Tunas Agro Kindergarten were trained to provide first aid in the event of an emergency or accident, either at school or in residential areas.

The training was coordinated by the EHS Department, Agro Harapan Foundation and CSR teams. Training materials were directly delivered by the Medical Team of PT Agro Indomas, Central Kalimantan.

## Donations and Healthcare Support for Communities in Nabire, Papua



In October 2021, Goodhope supported medical services for more than 52 people in Sima village, Nabire, Papua. The services were provided as part of company contributions to support community health programs.

Further to this medical support, the local community at Sima village received 139 basic supply packages on 1<sup>st</sup> December 2021. The donations were delivered through engagement between the companies PT Nabire Baru and PT Sariwana Adi Perkasa and TRIPIKA (collaboration of Head of Sub District, Local Police and Military Chief).

## Nabire Tree Nursery



Together with our project partners, PILI-Green Network, we have established a Tree Seedling Nursery to provide seedlings for restoration and rehabilitation activities in and around the company concessions in Nabire, Papua. The nursery shall serve as a stock of native tree seedlings for enrichment planting and will also serve as a source for commodity production to support local livelihoods. Forest rehabilitation programs and community livelihoods programs have been planned with participation from local communities in cooperation with our project partners (Ata-Marie and PILI-Green Network).



## Awards



PT Agro Indomas received an award for the implementation and development of the Productive Healthy Women Worker Movement (GP2SP) from the Ministry of Health of the Republic of Indonesia. The award ceremony took place in Jakarta on 29<sup>th</sup> November 2021.

The award is in recognition of efforts to fulfil the rights and improve the health of female workers: improving the nutritional status of female workers, increasing female workers' knowledge of reproductive health, facilitating breastfeeding and carrying out regular health checks for female workers.
